

VOX ANNOUNCES PRICING OF US\$7.26 MILLION UNDERWRITTEN PUBLIC OFFERING OF COMMON SHARES

TORONTO, CANADA - June 13, 2023 - Vox Royalty Corp. (TSX: <u>VOXR</u>) (NASDAQ: <u>VOXR</u>) ("Vox" or the "Company"), a returns focused mining royalty company, is pleased to announce the pricing of its previously announced primary underwritten public offering (the "Offering") of 3,025,000 of its common shares ("Common Shares") at a public offering price of US\$2.40 per share (the "Public Offering Price"), before deducting underwriting discounts and commissions. The Offering is expected to close on or about June 16, 2023, subject to customary closing conditions and the receipt of regulatory approvals, including the approval of the Toronto Stock Exchange ("TSX").

In connection with the Offering, Vox entered into an underwriting agreement, dated June 13, 2023 (the "**Underwriting Agreement**"), with Maxim Group LLC and BMO Capital Markets, as lead underwriters and acting as representatives of a syndicate of underwriters (the "**Underwriters**"), pursuant to which the Underwriters agreed to purchase 3,025,000 Common Shares from Vox for total gross proceeds of US\$7.26 million. Pursuant to the Underwriting Agreement, Vox granted to the Underwriters an option to purchase up to an additional 453,750 Common Shares offered pursuant to the Offering on the same terms and conditions for a period of 30 days following and including the closing date of the Offering.

Maxim Group LLC and BMO Capital Markets are serving as joint book-running managers for the Offering.

The net proceeds to Vox from the Offering, after deducting the underwriting discounts and commissions and estimated offering expenses payable by Vox, are expected to be approximately US\$\$6.19 million. Vox intends to use the net proceeds from the Offering for future acquisitions of royalties and/or general working capital purposes.

The Common Shares to be sold in the Offering will be listed on The Nasdaq Capital Market ("**Nasdaq**"), and the Company will apply to also list these Common Shares on the TSX. Listing such Common Shares will be subject to the Company fulfilling all of the requirements of the TSX.

The Offering is being made by means of written prospectuses and prospectus supplements that form part of Vox's existing short form base shelf prospectus dated January 23, 2023, filed pursuant to the shelf prospectus procedures established by National Instrument 44-102 - Shelf Distributions and the requirements established by National Instrument 41-101 - General Prospectus Requirements and National Instrument 44-101 - Short Form Prospectus Distributions, and Vox's U.S. registration statement on Form F-10, as amended (File No. 333-268011), filed with the United States Securities and Exchange Commission (the "SEC"). Preliminary prospectus supplements and the accompanying prospectuses have been filed with the securities regulatory authorities in all provinces of Canada, other than Québec, pursuant to the Multijurisdictional Disclosure System, and with the SEC in the United States.
